**PRODUCT APPLICATIONS:** Use to clean floors and polished surfaces, routine damp mopping of floors, spray and wipe for routine cleaning. Spray product on surface and wipe clean with damp cloth.

**HANDLING:** Protective gloves and goggles should be worn. Wash thoroughly after handling. Keep out of reach of children. Contact with undiluted product may cause eye damage, skin irritation and damage to some surfaces. This product is designed exclusively for industrial uses by trained professional maintenance personnel. Label directions and Material Safety Data Sheet (MSDS) precautions must be followed exactly.

**DISPOSAL AND SPILL INFORMATION:** As with all cleaning and maintenance procedures, run-off from the cleaning of maintenance process should be diverted to a collection vessel, or where permitted, to a sanitary sewer (consult local and state regulations) and not allowed to soak into the ground or to enter a storm sewer.
